HEARING OF VISITORS:

Genevieve Kermidas, 605 Lakeview Drive, Endicott, spoke on behalf of the Glendale Lake Association (Bosket Lake). She said the Association drained the lake to do maintenance on their shorelines and docks. They are concerned on how shallow the lake has become due to the amount of sediment that has filled the lake after the 2006 and 2011 floods and from the Town's storm sewer drains that flow into the lake. They are asking the Town to help remove the sediment. Photos were submitted to the Town Board for review.

Supervisor Rose A. Sotak said she would have Planning Director Paul A. Nelson to look into this and see if funds are available.

Town Attorney Alan J. Pope said from a legal standpoint, unless there is a documented agreement or easement with the Town, they cannot go onto private property to do any work. He asked how far out their property lines go and who owns the land under the lake. He suggested that the Association retain a real estate attorney to review their deeds and abstracts and see if there are any agreements in them.

Paul Gonzalez, 508 June Street, Endicott, asked what the Historic Preservation had in mind for the old EJ Building on N. Page Avenue.

Town Attorney Alan J. Pope said we are waiting for the determination from the judge as to who is the current owner of the property; either Broome County or 1 N. Page Avenue.
