Moved by Augustini, seconded by Bernardo authorizing the attendance of Sara Zubalsky-Peer and Mary Lou Fahs to the Housing Choice Voucher program training session from December 10 through December 14, 2018 in Passaic, NJ. Grantees are responsible for all travel related expenses. Authorization is requested for conference registration (\$1,200/person), hotel (4 nights at 140/person), tolls, parking, fuel reimbursement, and per diem meals at the town rate (\$48 first and last day, \$64 full-day/person.) and use of a town vehicle. The estimated cost of the training is \$4,500 and is an eligible expense under Housing Choice Voucher program guidelines. Funding is available in the Housing Choice Voucher administration budget line.
