MR. MOODY: All right. Just director's remarks. It's been a very trying year as Steve, I'm sure, will indicate also at the end. But, moving on, we have no minutes to approve because they were approved at the last meeting back in December or, I'm sorry, January 23rd, 2020.

So moving on to new business. LDC reappointment are the following: Mary Trumble O'Malley or Mary O'Malley-Trumble. I need a motion to approve.

MR. GARY LEIGHTON: I so move.

MS. DIANE JULIAN: I second. Diane. MR. MOODY: Okay. So who first -- who motioned? MR. LEIGHTON: Gary Leighton. MR. MOODY: Gary? MS. JULIAN: Yeah. MR. MOODY: And Diane second. Okay. MS. JULIAN: Diane. MR. MOODY: Yeah. All in favor. ALL: Aye. MR. TRICHKA: Opposed? MR. MOODY: None. Steve, you could handle that from the line. Okay. Going on to Tim Strong, Steve. MR. TRICHKA: Yeah. MR. TRICHKA: All right. Does anybody have any questions on that? All right. Do we have anything else in the agenda, Joe?
