MS. LANE: That issue has been clarified. Barbed wire is permitted if the fence

is at least 6-feet above the ground, and the DG Equipment fence is

6 feet 6 inches above the ground.

MR. NOONAN: Do we need a Special Permit?

MS. LANE: You do not need anything for the barbed wire

MR. NOONAN: As I said, we are just here to address any concerns.

MS. MILLER: Does anyone have any questions or comments regarding this

project; anyone on the Board? Okay. We will close the Public

Hearing.
