The Town of Union Planning Board will conduct a public hearing relative to a Special Permit application submitted by Kassandre Murdoch on behalf of K-9 District, LLC to develop in the 100-year floodplain at 4234 Watson Boulevard (Tax Map #142.02-1-11.1). structured, safe, fun environment for all of the dogs around the area to come to do daycare with us. We also do training, bathing, nails. So it is pretty much the dogs coming in and having a fun day after

getting dropped off, and then being picked up at night.

MS. LANE: I just want to say for the record that Kassandre has been doing this, it

was affected by COVID, but probably for about a year, right

Kassandre?

MS. MURDOCK: Yes.

MS. LANE: In Johnson City, but they had to leave that place.

MS. MURDOCK: Yes, so we pretty much upgraded.

MS. LANE: That is good.

MS. MILLER: Any questions from the Planning Board members or the public?

MR. CICCIARELLI: Will you be doing grooming there as well? Or is it just daycare,

bathing and nail clipping?

MS. MURDOCK: Yes. So it is just going to be daycare and bathing and stuff like that.

We will hopefully be adding grooming at a later date, but that will be

at another time.

MS. MCLAIN: What are your hours?

MS. MURDOCK: Our hours are Monday through Friday, 7 a.m. to 6 p.m.

MS. ROSE: Will you be doing any dog boarding there? I see that it says no

animals on the premises between 8 p.m. and 7 a.m. Would you be

doing boarding overnight or on weekends?

MS. MURDOCK: As of right now, we are just doing a day-to-day basis. Hopefully,

eventually down the road, we will also add that in at a later date.

MS. LANE: Boarding is a different use so that would require another review.

MS. MURDOCK: Yes, absolutely.

MS. ROSE: Thank you.

MS. MURDOCK: You're welcome.

MS. MILLER: So if there are no more questions or comments, we will close the

public hearing.
