### TOWN OF UNION BOARD MEETING

### <u> April 6, 2016</u>

The Regular Meeting of the Town Board of the Town of Union was held on Wednesday, April 6, 2016 at 7:30 P.M. in the Town Board Room, 3111 East Main Street, Endwell, New York.

<u>BOARD MEMBERS PRESENT</u>: Supervisor Rose A. Sotak, Councilman Thomas R. Augostini, Councilman Leonard J. Perfetti, Councilman Robert Mack. Absent: Councilman Frank R. Bertoni.

<u>TOWN OFFICIALS PRESENT</u>: Town Attorney Alan J. Pope, Town Clerk Gail L. Springer, Deputy Town Clerk Rebecca Kruczkowski, Paul A. Nelson, Planning Director.

Also in attendance was Johnson City Mayor Greg Deemie, Giuseppe Roberto, Zoning Board of Appeals member.

Supervisor Rose A. Sotak opened the meeting with the Pledge of Allegiance to the Flag.

### PUBLIC HEARINGS:

A Public Hearing was called for on Wednesday, April 6, 2016 at 7:30 P.M. to solicit public input for inclusion in the Federal Fiscal Year 2016 Community Development Block Grant (CDBG) Annual Action Plan. Pub. & Posted 4/1/16.

Berwin Darrow, 313 Doyleson Avenue, Endwell, presented to the Board pictures with details regarding a proposal for Patterson Creek clean up, to mitigate bank erosion and improve flow using funds from the 2016 Community Development Block Grant. He mentioned several neighbors that were also here with him.

Planning Director Paul A. Nelson said the Patterson Creek Bank stabilization project is under design right now using funds from the NY Rising CDBG-DR funding.

Supervisor Rose A. Sotak said she would have Commissioner of Public Works Louis Caforio and Planning Director Paul A. Nelson get with him to discuss this.

Robert Norton, 206 Norton Avenue, Endwell, said he came in 2010 to discuss the same problem and said NYS DEC would not allow any work to be done within the creek. He further said the creek should be regularly maintained or they will have flooding again like they had in 2011.



Cassandra Hamilton and Jane Talbot, Program Coordinators for Action for Older Persons, thanked the Town for previous CDBG funding; explained many programs they have to offer and asked for future assistance from the Community Development Block Grant.

April Ramsey, Family Enrichment Network, 24 Cherry Street, Johnson City, said they have received funds in the past and thanked the Town for their support. She said they have served over 5000 people a year with their programs, the largest program being Head Start. She is requesting funds to help with sidewalk repairs on the Roberts Street side of their Johnson City property.

Marquis Jones, Teen Transitional Living Program, Catholic Charities, 86 Walnut Street, Binghamton, spoke on behalf of the program that provides homeless youth with an opportunity to become responsible adults through independent living and social skills. He thanked the Board for their past support and asked them for their continued support.

Dana Brown, Executive Director, Community Development, Inc., 23 Jackson Avenue, Endicott, said his group is setting up a workforce development program on personal safety and developing job skills. He asked for consideration for use of CDBG funds for this program.

Supervisor Rose A. Sotak explained the Public Hearing process for the benefit of the students in attendance.

As no one else wished to speak, Supervisor Rose A. Sotak closed the Public Hearing.

### HEARING OF VISITORS:

A resident of Endicott, asked the status of the old EJ Building and the bonds that the owner was suppose to secure.

Town Attorney Alan J. Pope said the owners have until April 15, 2016 to secure the bonds and up to this point, they have not.

A resident of Endicott, said the owners of the EJ building come up every year and do just enough to cover up the problems. He asked how much longer this can keep going on.

Town Attorney Alan J. Pope explained that the owners have up until April 15, 2016 to post two bonds, one for \$100,000.00 to secure the premises and the other for \$700,000.00 for

demolition of the building. He said that if they do not comply by the 15<sup>th</sup>, then the Town can proceed. He further said the owners have until September to demolish the building.

A resident of Endwell, asked who would pay for this.

Town Attorney Alan J. Pope said the Town is researching all avenues to not make this a burden on the taxpayers.

A resident of Endicott, gave an update on the smells coming from the National Pipe and Plastics plant. He said the fans on the building are blowing straight up Grippen Avenue and the smells are horrendous. He also asked if trees could be planted along the back of National Pipe and Plastic's property to block the sight of the pipes.

Supervisor Rose A. Sotak said they have not been receiving any recent complaints and are contacting DEC when they do come in. She further said the Board wants the business in the area but also wants the residents to have quality of life.
