TOWN OF UNION BOARD MEETING

<u>July 13, 2016</u>

The Regular Meeting of the Town Board of the Town of Union was held on Wednesday, July 13, 2016 at 7:30 P.M. in the Town Board Room, 3111 East Main Street, Endwell, New York.

<u>BOARD MEMBERS PRESENT</u>: Supervisor Rose A. Sotak, Councilman Thomas R. Augostini, Councilman Frank Bertoni, Councilman Leonard J. Perfetti, Councilman Robert Mack.

<u>TOWN OFFICIALS PRESENT</u> Town Attorney Alan J. Pope, Deputy Town Attorney Rosemarie Pope, Town Clerk Gail L. Springer, Deputy Town Clerk Rebecca Kruczkowski.

Also in attendance were Broome County Executive Debra A. Preston, Deputy Broome County Executive John Bernardo, Broome County Planning Director Frank J. Evangelisti, Carole Cassidy, Director of The Broome Opioid Abuse Council (BOAC), Broome County Legislators Ron Heebner and Jason Shaw, Johnson City Mayor Greg Deemie and Zoning Board of Appeals member Giuseppe Roberto.

Supervisor Rose A. Sotak opened the meeting with the Pledge of Allegiance to the Flag.

At this time Supervisor Rose A. Sotak welcomed the distinguished guests and invited Broome Country Executive Debra A. Preston to speak.

Broome County Executive Debra Preston introduced her team that came with her this evening. She said they are traveling to different towns and municipalities to inform the residents of what is happening in the County and what projects they are currently working on.

Mrs. Preston said the water and sewer installation project on Airport Road going to the Broome County airport and landfill is going well and should be finished soon.

She said they are currently working on developing a solar farm, the largest in New York State to generate income to use towards utility bills of some of the largest utility users in the County; such as emergency services and Department of Social Services.

She spoke about the Upstate Revitalization Initiatives projects – Pharmacy School in Johnson City, Decker School of Nursing and housing developments; all projects that will bring income to the area. She also said Consolidated Funding Applications from all municipalities for projects to be considered are due this month.

Mrs. Preston spoke on the Landbank funding being used to demolish and refurbish properties in Binghamton and that they are looking to expand to the Endwell, Endicott and Johnson City areas. She said that the funding is from grants through the Attorney General's Office.

She asked if any of the Board members had anything they were concerned about or wanted updates on.

Councilman Frank Bertoni asked for an update on the Grippen Park Ice Rink.

County Executive Preston said they are looking for grant money to help bring the rink back.

She said that even though good things are happening in the County, she is concerned that the heroin and opioid usage is on the rise, as it is all over the country. The County implemented the Broome Opioid Abuse Council (BOAC) to help combat the problem.

Broome County Executive Preston introduced Carole Cassidy, Director, BOAC to speak.



Carole Cassidy explained that BOAC is a collaboration of public and private members focusing on developing solutions to the increase of prescription drugs and heroin abuse in our community and that it has resources to hook the people up with the right help that they need.

Frank Evangelisti, Broome County Planning Director, spoke on the environmental investigations they do to properties to get them ready to renew and fix for redevelopment. He said the tenth anniversary of the 2006 flood is approaching and they will have a report on work that has been done since to repair and prevent further damage. He said Town of Union Planning Director Paul A. Nelson should be congratulated for the work he has done for the Town.

At this time, Supervisor Rose A. Sotak congratulated Broome County Executive Debra Preston and her late husband Paul on the Conklin Fair Grounds being named in his honor and she thanked the guests for speaking to the Board and the residents.

PUBLIC HEARINGS:

A Public Hearing was called for on Wednesday, July 13, 2016 at 7:30 P.M. to consider the Change of Zone request for 499 Taft Avenue (tax map #141.58-1-1.2) from Suburban Single Family (SSF) to Open Space (OS). Pub. & Posted 7/1/16.

Father Michael Kleban, St. Mary's Orthodox Church, Endicott, spoke on the need for this zoning change to expand their cemetery. He said that there are only 20 available plots left in the current cemetery and there are 140 parishioners who are eligible to use them. He thanked the Board for their consideration.

As no one else wished to speak, Supervisor Rose A. Sotak closed the first Public Hearing.


Cassandra Hamilton, Program Coordinator for Action for Older Persons, explained the need for increased funding from the Community Development Block Grant due to the elimination of grant money and programs from the federal budget; and asked for consideration for increased assistance

As no one wished to speak, Supervisor Rose A. Sotak closed the second Public Hearing.

APPROVAL OF MINUTES:

Moved by Augostini, seconded y Bertoni to approve the Minutes of the Regular Town of Union Board meeting held on Wednesday, June 15, 2016. Carried.





HEARING OF VISITORS:

A resident of Endwell, complained about the property at 2706 Williams Street. He said he is aware that code violations have been issued, but the owner did not comply and was issued an extension to get the work done. He presented pictures to the Board and asked what can be done and when to expect it to be completed.

Town Attorney Alan J. Pope said the owner is complying with the violation notices, but has asked for an extension due to health issues. He further said that as long as the property owner was working with Code Enforcement to remedy the violations, he would be granted the extension.

The resident also complained about a dead tree on the property of 2711 Williams Street that leaves a mess on his property after storms and on windy days. He said Commissioner of Public Works Louis Caforio has looked at the tree and said it is a "dirty tree", not a dead one.

Town Attorney Alan J. Pope said this is a civil matter between the neighbors.

The resident said he worked for the Village of Endicott for 30 years and was President of their employee's union for 6 years and that he knows what the town employees are going through without a contract. He said they are hard workers and asked the Board to support them.

A resident of Endicott, spoke on the traffic situation at the National Pipe and Plastics entrance on Main Street. He also said what a horrible sight the old EJ factory building in West Endicott is.

A resident of Endicott, said he was at a recent Town of Union Planning Board meeting and said he is opposed to any new commercial development on Route 26 as is being discussed, without water and sewer being extended to this area. He said the businesses currently on Route 26 wash and detail their cars and all the solvents go into the ground affecting personal wells. Mr. Colley also spoke about three houses on Nanticoke Drive that are condemned and should be taken down due to the creek being moved and flooding them

He also said he is a past employee and former CSEA representative of the Town of Union and he supports the workers.

A Highway Department employee, said salary levels for employees are up to \$12.00 an hour less than surrounding municipalities and that he is making below poverty level income for his family of five. He said something has to change.

A Westover resident for 60 years, said his property taxes keep going up and he is two years in arrears on his properties. He said he can't keep up with the interest charges of 14% and is in danger of losing the properties.

The CSEA Labor Union Representative for the 40 Hour Bargaining Unit, Town of Union employees, said they have been in negotiations since last August and there is a serious problem with retaining employees, either by them leaving or retiring. She said the average salary of these employees is less than \$30,000 a year and these employees are dedicated and hard working. She said they will be at an impasse soon and is asking the Board to please look at everything, listen and work with them.

A Highway Department employee, said he services the equipment for the Town and said it is in very bad shape. He asked why they are not rolling over the equipment. He further said that inexperienced workers are working with the equipment and it is dangerous.



A Parks Department employee, asked if the board enjoyed the 4th of July Celebration at Highland Park and said a lot of hard work went into it to make it a success. He said he has seven employees under him at the parks and he is not even making the national minimum wage. He asked if Councilman Robert Mack looked into this as they discussed.

Councilman Robert Mack said he has not had a chance yet.

A Town of Union employee, said he has made the same salary for the last 4 years. He further said during the floods, the employees were praised for their work and now they are not appreciated. He said he has to work extra to get by and he asked the Board to look at the faces of the employees and see them.

A 17-year Refuse Department employee, said the employees just want an average wage as the other municipalities.

A 24-year Highway Department employee, said they have heard "We will make it up to you" and they just want to be shown they are appreciated.

A resident of Endwell, asked who is responsible for the ponds on Watson Boulevard and the cleanup of the algae. He is concerned about mosquitoes and the spread of viruses.

Councilman Leonard Perfetti said this is private property and the owners would have to clean it.

As no one else wished to speak, Supervisor Rose A. Sotak closed the first Hearing of Visitors.
