A resident of Endwell, spoke about pine trees on the corner of Northwood and Pleasant Drive, behind Weis Markets, that were trimmed and look awful.

Supervisor Rose A. Sotak said she would let Deputy Commissioner of Public Works for Codes & Ordinances Daria Golazeski know of this issue.

A Refuse Department employee, asked if new garbage trucks are being considered for purchase in the future. He spoke about issues with seat belts and door safety belts breaking on the current trucks that have caused injuries to two employees when they fell out of the trucks.

Councilman Leonard J. Perfetti said recommendations from the Department Head are needed regarding purchasing new trucks to be considered in the new budget.

Councilman Robert Mack asked if the Highway Mechanics were able to replace or repair the belts and if these incidents are reported to the Department Head.

A Highway Department Mechanic, said the belts are replaced or repaired when they are reported broken. He said the problem is that the trucks are designed for only one passenger along with the driver but they are being used on busy routes that require a driver and two pickers. The second picker stands in the door way when traveling to and from the routes.

Councilman Frank Bertoni said the trucks are not designed to have two passengers.

Councilman Robert Mack asked if a safety arm could be fabricated to use in the doorway of the trucks to prevent the person from falling out.

Town Attorney Alan J. Pope said issues should be reported through the chain of command; report them to their supervisor first and then go higher in command if not taken care of.

Councilman Leonard J. Perfetti said he would follow up on this issue with Commissioner of Public Works Louis V. Caforio.

As no one else wished to speak, Supervisor Rose A. Sotak closed the second Hearing of Visitors.
