#### TOWN OF UNION BOARD MEETING

#### November 2, 2016

The Regular Meeting of the Town Board of the Town of Union was held on Wednesday, November 2, 2016 at 7:30 P.M. in the Town Board Room, 3111 East Main Street, Endwell, New York.

<u>BOARD MEMBERS PRESENT</u>: Supervisor Rose A. Sotak, Councilman Thomas R. Augostini, Councilman Frank J. Bertoni, Councilman Leonard J. Perfetti, Councilman Robert Mack.

<u>TOWN OFFICIALS PRESENT</u>: Town Attorney Alan J. Pope, Town Clerk Gail L. Springer, Deputy Town Clerk Rebecca Kruczkowski, Comptroller Laura J. Lindsley.

Supervisor Rose A. Sotak opened the meeting with the Pledge of Allegiance to the Flag.

#### PUBLIC HEARINGS:

A Public Hearing was called for on Wednesday, November 2, 2016 at 7:30 P.M. to consider the 2017 Preliminary Budget and annual fire contracts for the fire protection districts, and proposed Tax Cap Override local law. Pub. & Posted 10/28/16.

As no one wished to speak, Supervisor Rose A. Sotak closed the Public Hearing.

### HEARING OF VISITORS:

Pat Fitzgerald, 707 Joyce Court, Endicott, asked for an update on the old EJ building and who the current owner and contact person is to ask about the results of the environmental studies that were done and to complain about the condition of the building.

Supervisor Rose A. Sotak said there is not a DEC report as of yet, but it is expected soon.

Town Attorney Alan J. Pope explained that the owners of 1 N. Page Avenue failed to pay their taxes and were foreclosed on by the County. They appealed the foreclosure in court and as of ten days ago, Judge Joseph Cawley ruled in the favor of Broome County, making them the current owner of the property. He also said the Town of Union still has orders for demolition of the building and will work with Broome County on these orders.

Dan Loiselle, 3201 Wayne Street, Endwell, asked what the plans are for the BAE site now that it is demolished.

Councilman Thomas R. Augostini said the Broome County Industrial Development Agency (IDA) owns the property and the Air Force is still having it cleared. He also said it is too premature to say what the property will be used for.

Supervisor Rose A. Sotak said the Town has had studies and plans done for possible uses but nothing is definite.

Councilman Frank J. Bertoni said the IDA will have to come to the Town with any plans for development.

As no one else wished to speak, Supervisor Rose A. Sotak closed the first Hearing of Visitors.
