#### **TOWN OF UNION BOARD MEETING**

#### May 17, 2017

The Regular Meeting of the Town Board of the Town of Union was held on Wednesday, May 17, 2017 at 7:30 P.M. in the Town Board Room, 3111 East Main Street, Endwell, New York.

Supervisor Rose A. Sotak opened the meeting with the Pledge of Allegiance to the Flag.

#### **HEARING OF VISITORS:**

Todd McCarthy, 602 Ventura Drive, Endwell, spoke about a County project that was encroaching on his property on Twist Run Road. He would like the Town to be a good neighbor and set up a process to check on such projects.

Town Attorney Alan J. Pope explained that this was a County job and the Town has no oversight on their projects. He said the Town has to be careful not to take on liabilities that do not involve them.

Council Robert Mack said the Town cannot oversee the County or State on their jobs.

Mr. & Mrs. Robert Bush, 315 Taft Avenue, Endicott, spoke about the ongoing code problems at 311 Taft Avenue and asked how this will be resolved when the owners do not show up to court dates.

Town Attorney Alan J. Pope explained that he is waiting for a bench warrant to be signed by the judge. Once they are served, they will be brought into court.

Scott Fegan, 309 Taft Avenue, said the smell from the house is atrocious. He also said that Broome County is supposed to be taking over the house for back taxes.

Town Attorney Alan J. Pope said that the violations will not go away if the County takes over the property. We will stay on top of this.

Councilman Thomas R. Augostini said he sent a message to one of the judges asking them to address this issue.

Mitch Curatolo, 1010 Autumn Drive, Endwell, asked when the sinkhole in front of 2739 Northwood Drive will be taken care of.

Councilman Leonard J. Perfetti said that the Town just started blacktopping.
