TOWN OF UNION BOARD MEETING

July 10, 2019

The Regular Meeting of the Town Board of the Town of Union was held on Wednesday, July 10, 2019 at 7:00 P.M. in the Town Board Room, 3111 East Main Street, Endwell, New York.

<u>BOARD MEMBERS PRESENT</u>: Supervisor Richard A. Materese, Councilman Frank J. Bertoni, Councilwoman Sandra C. Bauman, Councilwoman Heather R. Staley. Absent: Councilman Thomas R. Augostini.

Supervisor Richard A. Materese opened the meeting with the Pledge of Allegiance to the Flag.

PUBLIC HEARINGS:

A Public Hearing was called for Wednesday, July 10, 2019 at 7:00 P.M. to adopt the proposed amendments to the CDBG Citizen Participation Plan. Pub. & Posted 6/19/19.

As no one wished to speak, Supervisor Richard A. Materese closed the first Public Hearing.

A Public Hearing was called for Wednesday, July 10, 2019 at 7:00 P.M. for input and comments regarding the Town instituting a twelve (12) month moratorium on wind turbine installations, to allow the Town sufficient time to determine the appropriate code and land use laws, and to complete the drafting of a wind turbine ordinance. Pub. & Posted 6/23/19.

As no one wished to speak, Supervisor Richard A. Materese closed the second Public Hearing.

A Public Hearing to be held on Wednesday, July 10, 2019 at 7:00 P.M. to solicit public input to consider an amendment to Chapter 169-1 "Smoking" to include all areas of the Parks, including all indoor and outdoor facilities, prohibiting the use of Tobacco, Vaping & other



similar tobacco based products that either produce smoke or vapors, or is taken or used orally. This would include the general public as well as employees of the Town. Pub. & Posted 06/30/19.

Kaitlyn Harasta, 3102 Andover Road, Endwell, spoke in favor of a complete smoking ban.

Joanne Lettis, 3637 Pheasant Lane, Endwell, supports the smoking ban and said she feels that parks are no place for smoking with young children around.

Brent Bryson, 3637 Pheasant Lane, Endwell, supports the smoking ban.

Kristopher Bryson, 2609 Columbia Drive, Endwell, supports the smoking ban. He relayed a message from his wife that research shows that 2nd and 3rd hand smoke can cause Sudden Infant Death syndrome and that with two small children, they vacate the park when there are people smoking.

Bonita Graham, 618 Pheasant Lane, Endwell, supports the smoking ban and said she has two young children who love to go to the park and would support the ban also.

As no one else wished to speak, Supervisor Richard A. Materese closed the third Public Hearing.

HEARING OF VISITORS:

Jackie Pangilinan, Executive Director of Meals on Wheels of Western Broome, asked the Board to please reconsider their decision to apply a 10% penalty to the Community Development Block Grant application that was due on Friday, April 26, 2019. She explained that she became Executive Director in December 2018 and that the circumstances of her hiring did not allow any training or transfer of information from the former director, which caused her to be completely caught off guard when she received an email from the Town of Union on April 29, 2019 stating that she missed the application deadline. She completed the application, and submitted it on April 30, 2019 with her amended Board Minutes from Meals on Wheels. She invited whoever was to review the application to contact her if they had any questions, but unfortunately, she was not offered an opportunity to explain the circumstances of the late submission and to assure them she was not being deceitful about not knowing of the deadline. Mrs. Pangilinan went on to explain that Meals on Wheels relies on the \$24,000.00 that they have received for many years to serve the 200 + clients in Western Broome County, many of whom reside in the Town of Union and that the \$2,400.00 (10%) can pay for 500 hot meals, or three months of packaging, or weeks of the better quality meat for the senior to better chew and digest. She encouraged the Board to tour the Meals on Wheels facility, deliver a route and talk to the volunteers and clients to help them make their decision.

Supervisor Richard A. Materese asked for a clarification on how this happened.

Mrs. Pangilinan explained it again.

Diane Hunter, 519 ½ East Main Street, Endicott, spoke in support of Meals on Wheels and asked if there was an appeal process for the agencies to discuss their awards. She said she is aware that the court systems have appeal processes to try to change decisions handed down. She also spoke about her elderly friend who relies on the services of Meals on Wheels and she encouraged everyone to tour the facility, to understand what they do, because lives depend on it.

Nathaniel Robertson, 309 W. Main Street, Endicott, said he visited the Meals on Wheels facility today and was impressed with their program and facility. He also said his mother died of cancer and if he was not there to cook for her while she was ill, she would have needed a service like Meals on Wheels. He further said he was surprised the decision was made to add the penalty to the grant they received; and recommended the Board reevaluate the decision.

Councilwoman Heather R. Staley asked if she could make a motion to revisit the May 1st decision on cutting the funding.

Town Attorney Alan J. Pope said she could put it on the next agenda and it could be discussed at the next work session.

Mr. Robertson asked Councilman Frank J. Bertoni why he voted for the penalty.

Councilman Frank J. Bertoni explained that the documents that were submitted late indicated that they knew about the filing date, and until Mrs. Pangilinan spoke this evening, he and the rest of the Board did not know the circumstances of the late filing. He further said the filing policy has always been that if an application was late, the 10% penalty is deducted from the grant money awarded. He also said this could be revisited, but he cannot guarantee the decision will change.

Diane Hunter, 519 ½ East Main Street, Endicott, asked that this issue be revisited.

Town Attorney Alan J. Pope said that Mrs. Pangilinan referenced that she heard the Board thought she was being dishonest about knowing the filing date. He said that nobody on the Board thought that. He further said there is not an appeal process, but the Board has an informal and more efficient process of review and they will revisit this issue.

Amanda Durell, 115 Patio Drive, Endwell, was at the last meeting regarding the early hours of garbage pickup near her. She gave an update and said the garbage companies are still coming as early as 3:30 AM. She asked the Board if they can work with Code to get this problem taken care of.

Supervisor Richard A. Materese said there is an agreement with Weis Markets and they are trying to convince the other businesses to also have pickup done at a decent hour.

As no one else wished to speak, Supervisor Richard A. Materese closed the first Hearing of Visitors.

HEARING OF VISITORS:

Nathaniel Robertson, 309 W. Main Street, Endicott, said he was in work session tonight and there was a heated discussion between Councilman Frank J. Bertoni and Councilwoman Heather R. Staley about the disproportion of the number of Republicans versus Democrats on the Boards and Committees in the Town of Union. He said he had a listing of all the members on the boards and committees that shows all but one person is a Republican. He also said he was told that political parties are not considered for these positions, and yet a Democrat who was recommended by members of the Board for the position was denied the position. He thinks Mr. Garrison should have the opportunity to be heard.

Town Attorney Alan J. Pope clarified that he said in the work session that in the 15 years as the town attorney, politics have never been infused by a councilperson into any discussions.

Councilwoman Heather R. Staley said she feels politics has to be infused into these discussions, because the Town is made up of 1/3 Republican, 1/3 Democrats and 1/3 of other various parties, and yet the positions are all filled by Republicans who are either friends of Board members, involved in the Republican party or a high value donor to the Republican party. She said in all fairness, the interested people who are from the other political parties will never have a chance to serve their government unless they fall into one of those categories.

Supervisor Richard A. Materese said that it's quite possible that so many Republicans are on the Boards and Committees because representation of the Town Board has been Republican for a long time and when they needed a position filled, they asked their friends who may have been Republicans. He also said he sits on many of these Boards and he has not seen any



politics on these boards. Although it would be nice to have new blood, the Boards as they currently sit, have not done anything detrimental to anyone else.

Councilwoman Heather R. Staley said she believes the Board owes Mr. Garrison an apology for the way he has been treated, and she feels he would have served the community well if given the opportunity.

Matthew Wahila, 2722 Robins Street, Endwell, asked for clarification on the Resolution calling for a Public Hearing regarding amendments of the Town of Union Code – Chapter 46-1 Planning Board, Alternate Members that was withdrawn from the agenda this evening by Councilman Frank J. Bertoni.

Supervisor Richard A. Materese said it is not over and there are a number of things that need to be discussed on this Resolution before they can vote on it. He said the Town Board wants to make the best version of the Resolution before they come back for a Public Hearing on it.

Bridget Kane, 39 Jane Lacey Drive, Endicott, read the code as it is now, "There shall be two alternate Planning Board Members who shall be appointed by Resolution of the Town Board for terms established by the Town Board." She said while attending the work session this evening, her understanding is in addition to this change of code, the Town Board wants to reduce it down to 1 alternate position. She asked why the Board would not appoint him this evening and then take him off the Board if the code changes.

As no one else wished to speak, Supervisor Richard A. Materese closed the second Hearing of Visitors.

ADJOURNMENT:

Councilman Frank J. Bertoni thanked Councilwoman Sandra C. Bauman for her 20 years as a volunteer at Meals on Wheels.



Councilwoman Sandra C. Bauman clarified that the Town Board looked at the Meals on Wheels application very carefully and that the deciding factor for the cut was that the application was late, not that anyone was being deceitful about not knowing about the filing date; and the Board felt that if an exception was made for one organization, they would have to do it for everyone. She said she has been a volunteer for over 20 years and has also been on the Board for Meals on Wheels and it is a very good organization.

Councilwoman Heather R. Staley thanked Mrs. Pangilinan for the tour of Meals on Wheels and wanted to let her know she did not vote for the cut and hopes they can find the money somewhere to replace the \$2400.00.

Supervisor Richard A. Materese reminded everyone they still have time to support the O.L. Davis Ice Cream Social this evening at the Endwell Fire Station on Country Club Road.

Moved by Bertoni, seconded by Staley to adjourn the meeting. Carried.
