TOWN OF UNION BOARD MEETING

February 20, 2019

The Regular Meeting of the Town Board of the Town of Union was held on Wednesday, February 20, 2019 at 7:00 P.M. in the Town Board Room, 3111 East Main Street, Endwell, New York.

<u>BOARD MEMBERS PRESENT</u>: Supervisor Richard A. Materese, Councilman Thomas R. Augostini, Councilman Frank J. Bertoni, Councilwoman Sandra C. Bauman, Councilwoman Heather R. Staley.

<u>TOWN OFFICIALS PRESENT</u>: Town Attorney Alan J. Pope, Town Clerk Leonard J. Perfetti, Deputy Town Clerk Rebecca Kruczkowski.

Also in attendance were Broome County Legislator Jason Shaw, Johnson City Mayor Greg Deemie, Zoning Board of Appeals member Giuseppe Roberto.

Supervisor Richard A. Materese opened the meeting with the Pledge of Allegiance to the Flag.

PUBLIC HEARINGS:

A Public Hearing was called for on Wednesday, February 20, 2019 at 7:00 P.M. to consider amending Chapter 141 of the Public Nuisance Law. Pub. & Posted: February 14, 2019

Town Attorney Alan J. Pope explained the Public Nuisance Law and gave examples under the old law as to why there was a need for the changes. He said the new law revamps the points system to try to make it as constitutional and tight as possible to be the best defensible lockdown law we can have. He also said these changes are the most up to date in the Southern Tier and possibly all of upstate New York, but, at this point, the Town Board is not ready to act on this law yet.

Jason Shaw, Broome County Legislator, 400 Corey Avenue, Endwell, said he and his constituents want this lockdown law to be as tight as possible to be able close up the alleged drug house on Autumn Drive that they have been working on for many years.

Pam Brigham, 409 N. Page Avenue, Endicott, complained about a house on N. Page Avenue that is a problem with an absentee landlord who is allowing at least 15 people to live in the single family home. She said there have been multiple code violations that the code department has been called on, such as scrapping of junk cars. She also said a police presence is there at least twice a week for many complaints varying from threatening notes, harassing neighbors with yelling and verbal threats, working on cars with impact tools late at night and brandishing guns out in the open. She asked that this house be locked down under the law.

Supervisor Richard A. Materese said he and the Board are frustrated with the situation but unfortunately, without there being evidence of criminal activity, the lockdown law will not work. He also said affidavits from the neighbors are needed to help build the case.

Town Attorney Alan J. Pope said that under the new proposed law, the Town has to prove a problem by a preponderance of evidence to warrant bringing this to a judge for a lockdown order. He said he has to have firsthand evidence of criminal activity, not hearsay, and enough points accumulated within the designated time period to pursue court action.

Carol Laskoski, 37 Edwards Street, Johnson City, asked for a definition of public nuisance and if brandishing guns would be considered a criminal action.

Town Attorney Alan J. Pope gave the definition and also said if a video is obtained of that action being done, it could be used towards compiling points.

Tim Brigham, 409 N. Page Avenue, Endicott, said that people are afraid to go out of their houses because of the harassment and threats and asked what rights the neighbors have in these situations. He said he has lived in his house for 23 years and that West Endicott has been a nice area to live in, but because of the slumlords taking over, people are leaving.

Councilman Frank J. Bertoni said the home owners have been cited for code violations.

Councilman Thomas R. Augostini said the owners will have to pay the fines or go to jail if the violations are not remedied.

Councilwoman Heather R. Staley said she lives in West Endicott and has had issues with similar problems. She also said it is frustrating, but the Board cannot vote on this right now.

As no one else wished to speak, Supervisor Richard A. Materese closed the Public Hearing.
