### COMMITTEE REPORTS, RECOMMENDATIONS AND RESOLUTIONS:

Moved by Bertoni, seconded by Bauman effective today, May 19, 2021 to adopt a change in the Town of Union policies applicable to the Town of Union employees and the public visiting the Town of Union facilities, based on the new CDC guidelines adopted by New York State. Today, Wednesday, May 19, 2021, New York State's guidance regarding facial coverings has been updated to reflect recommendations from the CDC. This guidance states that facial coverings and social distancing is no longer required for people who have completed the COVID-19 vaccine series. As a result of this update, the Town of Union is also aligning its guidance for Town buildings with the new standard from New York State. Carried.

Supervisor Richard A. Materese said regarding the masks, we are all in favor of moving forward, but that being said, we will still follow CDC guidelines.
