Supervisor Richard A. Materese recognized the 4-H UNITY Endicott Urban Neighborhoods Improved Through Youth group that promotes civic engagement, workforce preparation and asset development among youth in Endicott and Rochester, New York, conducted by Cornell Cooperative Extension of Broome and Monroe Counties in close partnership with New York State 4-H, Cornell University. It is a Children, Youth and Families At-Risk (CYFAR) Program Sustainable Community Project. UNITY Teen Leaders have been busy interviewing business owners for their community service website. UNITY Endicott hosted their first "Fall Harvest Virtual Dinner" that gave the UNITY families an opportunity to cook together and enjoy a healthy nutrition lesson. Supervisor Materese recognized 4-H UNITY Endicott Teen Leader Bri Attey, to whom New York Senator Fred Akshar, 52<sup>nd</sup> District, presented his "Akshar's All Stars" award. Bri is a senior at Union Endicott High School. The "Akshar's All Stars" award recognizes students who have distinguished themselves through their leadership, compassion, school spirit and community service. Asia Ambler, UNITY project coordinator, represented UNITY at the award ceremony at Union Endicott High School. Senator Fred Akshar presented Bri with an "Akshar's All Stars" t-shirt, framed Certificate of Achievement and a challenge coin. Bri's father attended the ceremony.

Supervisor Materese also congratulated the people who won their election or re-election, Councilman Thomas R. Augostini, Councilman Frank J. Bertoni and Town Clerk Leonard J. Perfetti. He said he hopes that after the election is over, all citizens can come together to make our Nation stronger.
