Supervisor Richard A. Materese read the following Proclamation:

The Town of Union would like to commend the efforts of The YWCA of Binghamton and Broome County for their efforts to draw attention to and help reduce violence in our community as well as support survivors and victims of violence.

Violence is never an answer to solving problems. Violence against race, against women, against children or elderly, against gender, against political or religious sides

should never be tolerated.

We ask that you join us in a week without violence as we proclaim October 17<sup>th</sup> - 22<sup>nd</sup> as a time to focus on survivors and work toward peace in our community.

Councilwoman Heather R. Staley said that October is Domestic Violence Awareness Month. She said we have RISE located in the Town of Union to provide counseling and shelter for families fleeing from domestic violence. It is a good service and it is located right here in the Town.

Councilwoman Sandra C. Bauman invites all Town residents to Highland Park tomorrow, October 6<sup>th</sup> at 10:00 A.M. for the rededication of the Highland Park Pool to the Ray Vanderpoel Swim Facility.

Supervisor Richard A. Materese said Ray was a dedicated Town employee for 35 years and with him being our go to person for anything regarding the pools, it is fitting that the pool facility is named after him.

Councilman Frank J. Bertoni said he hopes Mayor Jackson will relay it back to the Village Board that the Town of Union is committing to spending \$89,000.00 on the sewer line.

Mayor Linda Jackson said she will definitely relay it back and she will go into Anthony Bate's office first thing in the morning to tell him the good news. She thanked the Town for being so generous and let them know they are appreciated.

Councilman Bertoni asked the Board to relay to people running for office that political signs or any other signs are not permitted in the Town right of ways and they should follow the rules. He said the right of way is from the curb to the sidewalk and it is unfair for municipal employees to have to move the signs to maintain the right of ways.

Supervisor Richard A. Materese said as for an example, the area around the on-ramp to Hooper Road from George F. Highway was covered with political signs. He said he took it upon himself to instruct the Highway Department to remove them. He also said if a person is running for office and is not following the rules, then why would we elect them.

Councilwoman Heather C. Staley said people running for office, especially large campaigns, have volunteers putting out signs that don't necessarily know the rules for all the municipalities.

Supervisor Materese said the candidates are responsible for their volunteers to know where they can put them.

Councilman Bertoni said that permission is supposed to be gotten from the property owners before a sign is placed and just because it is a vacant lot, you can't go on it to place a sign without permission. He said there are reasons we have these laws; the signs create a problem seeing around them and are a distraction.

Councilman Thomas R. Augostini said along the George F. Highway you will see an electric billboard sign that was recently constructed in partnership/agreement with the Town of Union and Park Outdoor. He said there was a very important issue that came down to a July 1<sup>st</sup> deadline and we should thank Amanda Dorrell for all of her help from NYSEG to expedite the issue and get that operational by July 1<sup>st</sup>. If Amanda did not go the extra steps, the sign would be there but not operable.

Amanda Dorell, Zoning Board of Appeals member, said she will do everything she can to help the Town. She said they have been very good to her.

Dan Loiselle, 3201 Wayne Street, Endwell asked if this was a public sign.

Councilman Augostini said it is a privately owned sign but leased on Town property.

Supervisor Richard A. Materese said the Town is making money from the lease.

Supervisor Materese apologized that this announcement is so late; on August 7, 2022, Ross Peduto, a longtime member of the Town of Union Local Development Corporation passed away. He said Ross served the Town very well. He also said that last week Wesley Miga, Union Center Fire Company President, passed away and we appreciate all he did. He gave condolences to both men's families.

Moved by Augostini, seconded by Bertoni to adjourn the meeting. Carried.
