<u>Resolution</u> to approve revision of the Full-Time Employee Handbook under **Section 900 Employee Benefits** to include the following:

#### For Non-Union Employees & Department Heads

**Leave Without Pay** – An employee <u>must</u> receive prior approval signed by their immediate department head/ direct supervisor **AND** the Town of Union Supervisor documenting <u>each</u> day leave without pay is requested with reasoning for the absence, to be filed in the

employees personnel file. Twenty-one (21) hours of leave without pay taken in a calendar year without prior dual signed approval may result in disciplinary action, up to and including termination of employment. The above policy is not to include an employees leave resulting from a workers compensation accident, FMLA, short term disability or a Town of Union Board approved Leave of Absence. A calendar year is defined as January 1 through December 31.
