NOTICE IS HEREBY GIVEN that pursuant to a resolution duly adopted by the Board of Fire Commissioners of the West Endicott Fire District, in the Town of Union, Broome County, New York, a Special Election of the qualified voters of said Fire District, will be held at the West Endicott Fire Station, 113 North Page Avenue, Endicott, New York 13760 on May 5, 2020, at 6:00 P.M. (Prevailing Time) and the polls shall remain open until 9:00 P.M. (Prevailing Time) or as much longer as may be necessary to enable the voters then present to cast their votes upon the following Proposition:

PROPOSITION

**SHALL the bond resolution of the West Endicott Fire District, in the Town of Union, New York, entitled: "BOND RESOLUTION OF THE WEST ENDICOTT FIRE DISTRICT, IN THE TOWN OF UNION, BROOME COUNTY, NEW YORK, ADOPTED APRIL 2, 2020, AUTHORIZING THE FINANCING OF IMPROVEMENTS TO THE FIRE STATION AT A MAXIMUM COST NOT TO EXCEED \$138,000.00 AND APPROPRIATING SAID AMOUNT FOR SUCH PURPOSE; AND AUTHORIZING THE ISSUANCE OF A MAXIMUM OF \$138,000.00 BONDS OF THE WEST ENDICOTT FIRE DISTRICT TO FINANCE SAID IMPROVEMENTS; AND PROVIDING FOR THE LEVY AND COLLECTION OF TAXES TO PAY THE PRINCIPAL OF SAID BONDS AND THE INTEREST THEREON AS THE SAME BECOMES DUE AND PAYABLE," be approved?**
